In-Home Respite ADS as Respite	Senior Centers through inter-agency agreements or subcontracts with CCP qualified agency (including their own CCP departments) or licensed child day care centers	CCU Initial and annual assessments are required. Former clients do not need an assessment if there is no more than a 60-day gap in service, unless their home and/or health situation has changed or they are due for an annual reassessment	Caregivers & Non-Parents (see definition on page 1)	Service Providers monitor their allotted funds in order to stay within their budgets In-Home Respite: is limited to 100 hours per fiscal year. Additional hours of service are only granted for urgent needs and MUST have prior approval from the Egyptian AAA ADS as Respite: One hour of time spent in providing care (excluding time to transport). First 100 hours may be provided as needed with additional hours requiring no prior approval but limited to 2 days per week	Report units under Title III-E, only Non-Parents raising children can also receive respite.
